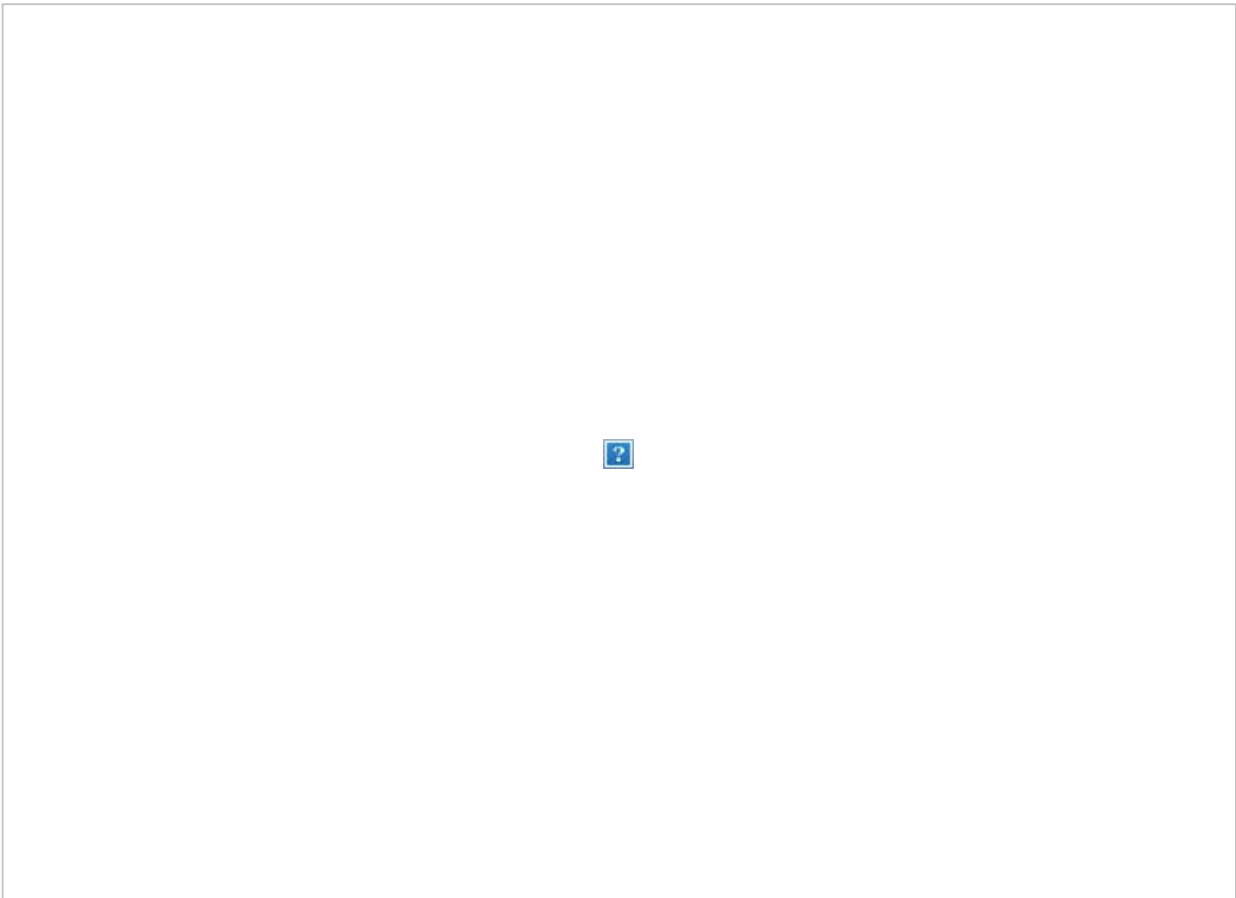

Pursuant to the requirements of Government Code § 11346.8(c), and Title 1 of the California Code of Regulations § 44, the California Board of Forestry and Fire Protection (Board) is providing notice that a document which the Board has relied upon in adopting the proposed regulations pertaining to the “RPF and LTO Responsibilities Amendments, 2017” has been added to the rulemaking file and is available for public inspection and comment.

The following documents have been added to the rulemaking file:

- Revised 45-Day Rule Text- as revised by the Board at the July 2017 regular meeting.
- Supplement to the Initial Statement of Reasons.

Attached please find a PDF version of the 15-day notice, amended rule text, and supplemental statement of reasons. The 15-day notice period will run from Monday, July 31, through Tuesday, August 15, 2017, and the Board will conduct a public hearing to consider adoption of the proposed rule text modifications at their regularly scheduled meeting on August 23, 2017, at the Natural Resources Building, 1416 9th Street, Sacramento.
