14. Hearing: “Forest Fire Prevention Pilot Project Exemption, 2014”

Adopt: § 1038(j) Forest Fire Prevention Pilot Project Exemption

Following a 45-day Noticed rulemaking hearing at its regularly scheduled meeting of August 27, 2014, the Board adopted a motion to offer a 15-day Notice pursuant to Government Code Section 11346.8(c) to provide all stakeholders the opportunity to comment on these changes to the proposed regulation.

The Board is promulgating a regulation to be adopted into the FPRs, the Forest Fire Prevention Pilot Project Exemption, in accordance with PRC § 4584(j) as amended by AB 744 in 2013 and PRC § 4584.1 as added by AB 2142 in 2014.

Specifically the proposed regulation modifies the maximum stump diameter of trees allowed to be harvested and increases the maximum post harvest fuel depth to be achieved. Other proposed changes to the rule plead are designed to bring consistency to the Forest Fire Prevention Pilot Project Exemption relative to the existing regulatory requirements of the Forest Fire Prevention Exemption, which the proposed rule builds upon.

The regulations set standards for future design and construction of structures, subdivisions and developments in SRA and provide for basic emergency access and perimeter wildfire protection. This regulation makes several revisions to the existing regulations for the purpose of improving regulatory clarity and uniform implementation of wildfire protection standards association with residential subdivision development.

Following a 45-day Noticed rulemaking hearing at its regularly scheduled meeting of August 27, 2014, the Board adopted the regulation in its noticed form with the addition of two minor modifications. These modifications were based upon comments received from the Office of Administrative Law and the San

Ramon Valley Fire Protection District. The Board adopted a motion to offer a 15-Day Notice pursuant to 11346.8(c).

Following a 45-day Noticed rulemaking hearing at its regularly scheduled meeting of August 27, 2014, the Board adopted the regulation entitled, “Slash Treatment Amendments, 2014.” The regulation was adopted in its noticed form with the inclusion of the changes described below. The Board adopted a motion to offer a 15-day Notice pursuant to Government Code Section 11346.8(c).

Section 917.2 [937.2, 957.2](a)(1). At request of the Department, the regulatory proposal has been revised to require treatment of slash piles from May 1 to by April 1, or within 30 days following climatic access after April 1 of the year following its creation.

Section 917.2 [937.2, 957.2](a)(2). At request of the Department, the regulatory proposal has been revised to require treatment of slash piles from May 1 to by April 1, or within 30 days following climatic access after April 1 of the second year following its creation.

§ 1051.1 Contents of Modified THP

The primary purpose of the amendments is to provide small timberland owners greater opportunities for cost-effective timber management than currently exist. The amendments increase the size of ownerships for which a MTHP can be used to a maximum of 160 acres and modify the existing prescribed conditions and mitigations required of MTHPs.

SPEAKING AT THE MEETING

If you wish to speak on an agenda item, please fill out a "Speaker Card" and give it to Board staff **BEFORE** the agenda item is heard. Cards will be available near the entrance of the meeting room.

- Individuals with a shared position are encouraged to select a spokesperson for their group.
