Webcast via MS TEAMS

The PFEC will make the February 26, 2025 meeting available for public observation via Microsoft TEAMS. Registration links for teleconferencing are available on the Board of Forestry and Fire Protection website (https://bof.fire.ca.gov/) under Webinar Information. The ability to provide public comment via Microsoft Teams will be accommodated to the extent required by law under the Bagley-Keene Open Meetings Act.

By default, PFEC meetings will be convened pursuant to the "In Person" meeting requirements of the Bagley-Keene Open Meeting Act. If this agenda identifies one or more teleconference locations where committee members will be attending the meeting remotely, the meeting will comply with the teleconference meeting requirements of Government Code section 11123(b). The public is entitled to observe and participate in the meetings via public comment via Microsoft Teams at the primary meeting location and any teleconference location identified in this agenda. As a courtesy, the PFEC may permit the public to observe the meeting and provide public comment using the Microsoft Teams platform from locations not identified in the agenda as teleconference locations.

Submitting A Comment: During the meeting, all participants using TEAMS will be muted by the meeting organizer. Participants will have an option to submit a comment, either by writing your comment or by directly addressing the members verbally. To submit a written comment, type the text of the comment in the "Chat" pane of the TEAMS interface. To submit a comment by verbally addressing the members, select the "Raise Hand" icon on the top of the TEAMS interface. The meeting organizer will call you by name and unmute you, so you can address the Committee members. If you are commenting verbally, please be sure to unmute your phone or device. An example image of the TEAMS interface is in Figure 1 at the end of this agenda. If the agenda identifies an optional physical location, members of the public attending at that location should physically raise their hand to indicate to staff at that location the desire to make a verbal comment. If your comment relates to a particular agenda item, please indicate your request to comment at the beginning of or during the consideration of that agenda item in order to ensure comments relate to the particular agenda item being discussed. If your comment relates to a topic within the PFEC's jurisdiction and is not otherwise on the agenda, please indicate your request to comment during the Public Forum period, which will occur at the end of the meeting. The meeting organizer will manage the queue of comments. In addition, please see the section on Submission of Written Materials for information on submitting other written materials.

Audio recordings of the open session PFEC meeting may be preserved and available on the Board's website. Due to space limitations on its servers, the Board does not preserve video recordings of meetings and/or audio recordings of its committee meetings or workshops.
