1. Call to Order, Webinar Meeting Format, and Roll Call – Dr. Wolf, Board Staff

# State Budget

Dr. Wolf noted that RMAC members and Board staff do not have travel funding through Fiscal Year (FY) 2026 because the State budget has been frozen for non-essential travel, so there can be no field days without external, partner-provided funding to support travel or workshop needs. Because the RMAC would still like to conduct a couple of workshops in person, it will need feedback on potential partners for resources for funding, resources, and site hosts.

# Outcome of the SRM session on collaborative forestry and range management

This symposium was conducted in collaboration with partners from the RMAC and the SRM Prescribed Grazing Committee, of which a number of individuals spoke along with RMAC members Cole Bush, Dr. Horney, and RMAC staff Dr. Wolf. The recording of the full meeting has been released by the Society for Range Management.

Dr. Wolf indicated that the presenters that day had provided some resources that she has compiled for the attendees to this symposium. However, a sign-up sheet for that day was either not taken, or was lost, so at this time Dr. Wolf has been unable to share this with the attendees. She is hoping to get this resource list out to attendees that day, so if folks are aware of who attended that day, please let her know and she can forward that. Dr. Horney indicated he will contact SRM

leadership and get a notice added to the SRM Range Flash to have folks interested in this to contact Dr. Wolf.

#### Action Items:

- Dr. Wolf will finalize the resources list with input from the panel members.
- Dr. Horney will attempt to play the whole meeting back to record it, and the RMAC may post the recorded segment of for the symposium on the RMAC webpage.

# One-page Informational Sheet on Prescribed Herbivory

The RMAC and CWGA Targeted Grazing Committee worked together to produce an informational sheet on prescribed herbivory for fuels reduction to potentially include in CAL FIRE's guidance on fuel reduction treatment activities. Because CAL FIRE has not provided further guidance on next steps, the RMAC decided to request permission to independently publish and disseminate the information. The Board of Forestry & Fire Protection ('Board') unanimously voted to approve this motion at it's March 6<sup>th</sup> meeting.

Member Delbar asked if there was a timeline from CAL FIRE for reviewing the timeline, and if/what their resistance to publication was. Dr. Wolf indicated that the RMAC has not received any feedback around any potential resistance to publication, nor any information on a potential timeline for review or future discussion. Dr. Wolf suggested that someone from the RMAC could bring this topic back up at a Board meeting to inquire as to what next steps might be.

5. 2023 Annual Report and Workplan and 2024 Annual Priorities – Dr. Horney, Chair; Dr. Wolf, Board Staff; and RMAC members

#### 2024 Annual Priorities

6. Updates and Next Steps: Educational Workshop Series 2023/24 - Dr. Larson, Vice-Chair

Vice-Chair Dr. Larson reported that she and Member Cremers spoke about a focus on cattle, given that cattle producers may need additional information on targeted grazing with cattle, and not just sheep and goats. Dr. Larson is willing to organize the effort(s), but needs input on this, including on the timing of this. The RMAC received information that timing might be best for legislative aides if workshops are set in the late summer/early fall.

## **Discussion**

Dr. Wolf noted that there are several examples where cattle are being utilized and integrated into grazing treatments for fuels reduction, including at East Bay Regional Parks District, and Dr.

Larson indicated Member Cremers also had some examples. Member Cremers noted that summer/fall could be a difficult time for cattle producers, and that the target species/ecosysterm services might also not be highlighted well at that time. Vice-Chair Dr Larson agreed that this is a good point. Other members also agreed with this reasoning. Dr. Horney noted Ben Munger is doing work on the Carrizo Plains around this. Chair Dr. Horney also noted that while folks on the small ruminant side are generally well-versed in this topic, but many cattle ranchers may not be. Dr. Larson and Dr. Horney noted it would be good to have a multi-species perspective. Dr. Larson noted that the goats and sheep may be used as a shorter-term action, followed by longer-term management solution with cattle to maintain fuel removal/reduction. Other applications include grazing of vernal pools, fire-fuels reduction, special-status species, and more. The audience could be agency personnel, and beyond. Tim Koopman was indicated as a possible contact, as he manages state park land for fie and habitat. Member Kramer noted that a rancher at Rancho Corte Madera is working with University of New Mexico on investigating virtual fencing options, given that is often a limiting factor around targeted grazing.

Dr. Wolf mentioned the possibility of a webinar laying the groundwork for a workshop(s) and could be done before the workshops, and include a primer on grazing with more information on a variety of topics, ecosystems, purposes, and more, which would then be followed by one or two in-person context- and site-specific workshops. Member Dr. Starrs noted that resource managers on public lands are often lacking knowledge about livestock grazing for reducing fire hazard and enhancing public land access and environment, and thus it could be worth having a portion of this seminar about using livestock for improving conditions in managed lands. Dr. Larson mentioned bringing CAL FIRE into these discussions as well.

7. Updates and Next Steps: Prescribed Herbivory Deliverables – Dr. Wolf, Board staff

Dr. Wolf summarized the background on this item: Several RMAC members and members of the California Woolgrowers Association (CWGA) Targeted Grazing Committee produced this one-page fact sheet with the hope that it would be put into CAL FIRE's Fuels Reduction Guidance. No agreement was reached about how or if CAL FIRE or the Board will utilize this document. The RMAC voted at the January meeting to approve for independent publication by the CWGA/RMAC team, and the Board unanimously approved this at the March Board meeting.

#### Action:

Dr. Wolf has been working with Member Bush and Roger Ingram at CWGA to ensure final proper credits for authors and artwork/pictures and will work to finalize the document and send out for dissemination.

# Prescribed Herbivory 2015 White Paper Update

Member Bush reported that the CWGA Targeted Grazing Committee is eager to support this effort. Dr. Wolf reported that the initial revised version from Member Bush was sent out to the RMAC members with a request for feedback, and those edits were incorporated and sent back to Member Bush and the RMAC members for review prior to this meeting. Member Bush and Dr. Wolf noted that there is a LOT of information that is still needed on this document, especially updated examples of how contracts are being written today, insurance certificates, new CEQA (California Environmental Quality Act, environmental compliance documentation) examples, and other relevant resources, particularly with information from a cattle lens.

Member Bush suggested this version be sent to the CWGA team WHILE RMAC members are sending in edits/revisions. Dr. Wolf indicated that simultaneous work by the CWGA and RMAC could help turn this around sooner, followed by a public comment period; this keeps the timeline tight and clear, and allows feedback from all stakeholders across California. Member Starrs noted that the core pages of the document are only 8 pages long, and that this seems manageable. Dr. Larson noted that getting information beyond prescribed herbivory around other fuels treatments would be a good idea; Dr. Wolf noted that this was one of the original intentions of this paper, and we need more input on that topic, and she would not consider it complete without that information.

Focusing solely on prescribed herbivory for the purposes of this white paper, rather than integrating other fuels treatment activities, was mentioned by Dr. Horney and Member Bush, with the idea of adding in additional treatments in a future version (next year), with an effort to add case studies and more information to expand on this for next year. Member Starrs noted that since 2015 there have been some rather epic fire management catastrophes, and it seems that in the last ten years the RMAC has become more aware of the issue and a more effective approach is needed. He also noted that this document won't require a huge brochure or effort for dissemination; we can focus on this being disseminated online instead. Dr. Wolf noted that if the RMAC focuses solely on prescribed herbivory for fuels management for now, with additional information on integrated fuels treatments next year, that would at least be a good interim step. Dr. Horney noted that a focus on expanding the evidence around grazing as a tool to reduce fire fuels would be helpful for now, along with other evidence that other fuels treatments integrated into a fuels management plan that includes prescribed herbivory can improve the outcome, but the focus on HOW this occurs would go into the technical guidance document (see below).

## Action Items:

- The RMAC members and CWGA Targeted Grazing Committee will provide revisions to this document, information for the appendices, and examples/case studies to Dr. Wolf via email by May 19, 2024.
- Dr. Horney will solicit graduate students to help with the literature review as well. Dr. Horney will send out a link with a folder to add in resources. He will also invite other colleagues to recruit other students and academics to help with this process.

# Prescribed Herbivory Technical Guidance

At the meeting before last it was decided that the items being covered by other guides in production by the NSA and SRM should be reviewed before delving too far into this effort. Member Cole was mentioned as having connections to the NSA, and could make that inquiry.

8. State Lands Grazing License & Land Management (SLGLLM) sub-Committee Deliverables – Bart Cremers, *Member* 

Dr. Wolf introduced the agenda item and summarized the discussion from the January meeting: Previous plans to create sample grazing agreements and/or grazing management plans using the templates in development will no longer move forward so as to avoid potential confusion or perceptions about constraints for using these templates. As such, we will return focus to the production and finalization of the Guidance Booklet, which is intended to walk users through the utilization of the Grazing Agreement template and the Grazing Management Plan templates being developed by this committee; the bulk of these templates were produced by the SLGLLM subcommittee, which has since been dissolved as these deliverables approach finalization.

Member Cremers noted that the agreement and management plan templates are relatively complete at this point, and are in Dr. Horney and Dr. Wolf's hands to finalize. He started on the guidance booklet and will continue on that to hopefully have a draft by the next meeting.

He reached out to CNRA within the comment period and suggested that they subdivide the polygons and verify with the land manager to clarify dominant treatment for the polygon.

a. Legislative Updates

#### b. Updates from Partner Organizations

Member Kramer provided an update from the RCD of Greater San Diego:

- They are seeing non-proft partners hiring more at regional level for ranching and conservation ranching, including Audubon and Point Blue.
- The RCD was successful in getting funding from the Department of Conservation for a prescribed grazing project in Alpine, which is at higher elevation than most other areas in San Diego County. This will be a nice

- comparison of grazing outcomes to those in the lower elevation, more coastal climates.
- Healthy Soils funding is active right now with block grant funding. More
  opportunities for carbon sequestration are now available on larger properties.
  However, a lot of ranchers are running into limits because a Grazing
  Management Plan is required to do prescribed grazing with internal fencing,
  and there isn't designated funding for perimeter fencing from any state or other
  sources.
- The National Association of Conservation Districts had their annual conference this year, and many local ranches were included on the field tours.

Details: Sept 28-29; attendees have requested guidance about estimating forage and grazing management plans, which are things that CRMs specialize in, in addition to the usual topics like disease and pest management.
