- Fire activity, reported on how weather conditions and the lack of precipitation will affect the 2015 fire season. As a result of three years of draught conditions Cal Fire is in year around fire season and has maintained strong staffing throughout the regions to support increased fire season. Fires in San Mateo, Placer and El Dorado have already been reported in January.
- Budget: The Governor's budget allowed for added staffing to bring firefighters and engines on early based on weather conditions. The budget also allows for procurement process to replace 12 helicopters, over a multiyear process.
- Grants: Working on a monthly report with ARB on methodology's by which carbon are identified
 will be meeting with ARB to continue discussions. Concept proposals were received and the
 department has begun soliciting action grant applications from those selected.
- The first Forest Climate Action Team (FCAT) public meeting is on February 20, 2015 to be
 hosted at the Resources building and will be broadcast via webinar. Russ Henly is spearheading
 the efforts. Additional meeting will occur in March. The FCAT website is active and can be
 found on the Cal Fire website.
- A significant achievement was made with Usal Redwoods Forestlands being transferred to Cal Fire to the Public Works Board in December. Approximately 50,000 acres will be transferred to the Forest Legacy Program.
- The Fire Resources Assessment Program (FRAP) was moved from the Fire Marshal's Program to the Resource Management Program. FRAP will continue to support the same services. Chris Keithly is the acting lead at FRAP.
- Mentioned the loss of several members of Cal Fire in 2014, including Pilot Craig Hunt and Firefighter Roger Gonzalez. The Director Iso reflected on the 10th anniversary of the loss of Eva Scheike who was assigned to Columbia Helitack 404. Cal Fire local 2081, the Honor Guard and Tuolumne-Calaveras Unit gave a fitting tribute at the memorial site.
