Hi Brandi,

So, not too much to report on the post-wildfire grazing bibliography. I have been playing phone tag with Matthew Shapiro to get his perspective, but have not managed to actually talk yet.

I have spent quite a bit of time on google and google scholar and following citation chains. The vast majority of the post-fire grazing literature is Great Basin, Sagebrush/cheatgrass dynamic, focused. There really is not that much out there and I have not found anything that is focused on California annual grassland types.

One area where the lack of information actually IS important in and of itself is that I have scoured BAER (Burned Area Emergency Response) handbooks and guides for the various agencies and have found no hard standard to rest burned areas from livestock grazing for a certain number of years. You often hear that there is a rule of thumb of resting three years, but that likely comes from the fact that BAER is funded for three years post fire maximum. All agency guides and handbooks I have found recommend a site specific assessment for rest from grazing on public lands post-fire.

Anyway, hope that suffices for a little bit of an update. Sorry I couldn't make the meeting this time.
