## Summary

My role as Forester with a regional park district has introduced me to the potential of monitoring forestry and fuels management with standardized monitoring methodology and scientific rigor to increase the pace and scale of producing quality scientific monitoring results that can be utilized in adaptive management.

In my role, I manage hazardous wildland fuels reduction projects, including planning, organizing, developing, directing, and administering fuel reduction contracts for tree and brush removal. I work as part of a team that coordinates a complex and difficult program in the area of resources management and fire protection, while enhancing parkland and open space resources. In addition, I advise on forestry-related matters to multiple departments, including inventory design, research, monitoring and efficacy study design and contract oversight, and permitting.
