Due to the repeal of Government Code section 11133, the Range Management Advisory Committee (RMAC) has resumed physical in-person meetings. These in-person meetings are not “teleconference” meetings within the meaning of the Bagley-Keene Open Meeting Act. As a result, the public’s right to observe the meeting and provide public comment is required under Bagley-Keene only for those who are present at the physical meeting location. However, as a courtesy, the RMAC may provide an option to observe a meeting remotely for members of the public who cannot attend in person via webcast by completing registration links available on the Range Management Advisory Committee website (<https://bof.fire.ca.gov/board-committees/range-management-advisory-committee/>). Please review the “Important Meeting Information” portion of this agenda for potential limitations for online participation at this meeting.

WEBCAST

RMAC meetings can be observed via live webcast. Committee members must attend in person at one of the meeting's noticed locations, along with any members of the public that choose to attend. Due to space limitations on its servers, the committee may not preserve audio or video recordings of its meetings. If a quorum is present at a single location, the physical meetings may continue if the webinar broadcast is interrupted or terminated for any reason.

The Bagley-Keene Open Meetings Act only guarantees the right to offer public comment for individuals attending at a noticed location. However, the committee typically attempts to accommodate public comment from individuals observing via webcast from unnoticed locations, as described below. As stated on the Meeting Agenda, staff will address webcast participants prior to normal Committee business to provide guidance on meeting format and stakeholder participation.

Please see section on **"Speaking at the Committee Meeting"** for instructions pertaining to the potential ability for webcast attendees to offer verbal public comment as part of the physical meeting.

Submitting A Comment: During the meeting, all participants will be muted by the meeting organizer. Participants will have an option to submit a comment, either by writing your comment or by directly addressing the members verbally. To submit a written comment, type the text of the comment in the "Chat" section of the Microsoft Teams interface. To submit a comment by verbally addressing the members, select the "Raise Hand" icon. The meeting organizer will call you by name and unmute you so you can address the committee members. If you are commenting verbally, please be sure to unmute your phone or device. Please keep comments to three minutes or less.

If the agenda identifies an optional physical location, members of the public attending at that location should physically raise their hand to indicate to members and staff at that location the desire to make a verbal comment. If your comment relates to a particular agenda item, please indicate your request to comment at the beginning of or during the consideration of that agenda item in order to ensure comments relate to the particular agenda item being discussed. If your comment relates to a topic within the committee's jurisdiction and is not otherwise on the agenda, please indicate your request to comment during the Public Forum period, which will occur at the end of the meeting. The meeting organizer will manage the queue of comments. In addition, please see the section on **"Submission of Written Materials"** for information on submitting other written materials.

Timely submittal of written materials provides Board staff and Committee members the opportunity to familiarize themselves with content of written documents. Note that depending on the volume of written materials received, Board staff and Committee members may not be able to review all materials received prior to the public meeting. Written materials received after the deadline above will not be considered. Written materials submitted may be posted online by Board staff to allow for public inspection.
